

World Taekwondo Activity Waiver 2018

I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to: actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, event monitors and/or producers of the event; lack of hydration, weather, and/or other natural conditions. I hereby assume all of the risks of participating in this event.

I certify that I am physically fit, have sufficiently trained for participation in this event and have not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by World Taekwondo Federation (WT), Global Membership System (GMS), the national federation (MNA) or association, continental union (CU) and/or the local club, and the sponsors of the event in which I may participate and it will govern my actions and responsibilities at said event.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) Waive, release, and discharge from any and all liability for my death, disability personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: WT, GMS, MNA, CU, local club, and their directors, officers, employees, volunteers, representatives, affiliates and agents, the event sponsors and event volunteers, (B) indemnify and hold harmless all entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of my actions during this event.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this event.

I understand that at this event or related activities I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and/or assigns.

I understand that as a participant in a WT event I am bound by the corresponding WT rules and regulations, including the WT Ethics Code, the WT Bylaws on Betting and Anti-Corruption, and the WT Bylaws on Dispute Resolution and Disciplinary Actions.

This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under the applicable law.

I hereby certify that I have read this document and I understand its content.

Thank you for visiting our web site. This privacy policy tells you how we use personal information collected. Your personal information is collected, processed and used by the World Taekwondo Federation located 5th Fl., Kolon Bldg., 15 Hyoja-ro, Jongno-gu, Seoul, Korea, 03044, its offices and divisions worldwide (hereinafter together, "the Federation"), as well as by the national federation (MNA) or association, continental union (CU) and/or the local club of which you are a member, and any service providers of the above-listed entities, located within or outside your country, in order to process and manage your registration as a member, your taekwondo license and your registration to events or competitions, including your health ability to obtain a license or participate in competitions, to process and publish your results and rankings, to process and answer your requests and questions, to keep you informed of news and events relating to taekwondo, to send you events and training information or other information for communication purposes; as well as for statistical and analytical purposes.

The Federation respects the privacy of the member and/or non-member data we collect and only shares it when necessary, as disclosed below:

What information we collect

The Federation collects member and non-member information, including member business, personal and financial information, in a variety of ways, including without limitation: at events; meetings; through the Federation website, emails and other correspondence and communications; and in connection with membership, sales and other transactions.

In addition, individuals or entities may be required to provide their credit or debit card information; bank account numbers and information; or taxpayer identification numbers for transactions or for other financial or tax purposes.

Cookie/Tracking Technology

The Site may use cookie and tracking technology depending on the features offered. Cookie and tracking technology are useful for gathering information such as browser type and operating system, tracking the number of visitors to the Site, and understanding how visitors use the Site. Cookies can also help customize the Site for visitors. Personal information cannot be collected via cookies and other tracking technology, however, if you previously provided personally identifiable information, cookies may be tied to such information. We may also share information, including that required for security, with governmental agencies or other companies assisting us in fraud prevention, investigation and/or prosecuting breaches of any relevant provisions, rules or bylaws (including but not limited to the World Anti-Doping Code and/or betting rules). We may do so when: (1) permitted or required by law; or, (2) trying to protect against or prevent actual or potential fraud or unauthorized transactions; or, (3) investigating fraud which has already taken place.

As an Olympic sport data collected is subject to the International Olympic Committee (IOC) rules, regulations and disciplinary actions, including but not limited to those regarding betting and anticorruption. Therefore, when applicable the IOC will help review these regulations and if necessary amend them.

Whom we will share the information with

The Federation enters arrangements with, and utilizes the services of, members, volunteers and third parties (collectively "Agents") to assist in the Federation's business and activities. These Agents may obtain member and/or non-member information without notice to the individuals whose information is being shared. Access to information is limited to only those individuals and entities that need the information for the business and activities of the Federation, as determined by the Federation and/or its Agents, in their sole discretion.

Commitment to Data Security

Your personally identifiable information is kept secure. Only authorized employees, agents and contractors (who have agreed to keep information secure and confidential) have access to this information. All emails and newsletters from this site allow you to opt out of further mailings.

You may request access to, correction and/or removal of your personal information processed by the Federation, or object to the processing of your personal information by the Federation for legitimate reasons or for communication purposes.
